

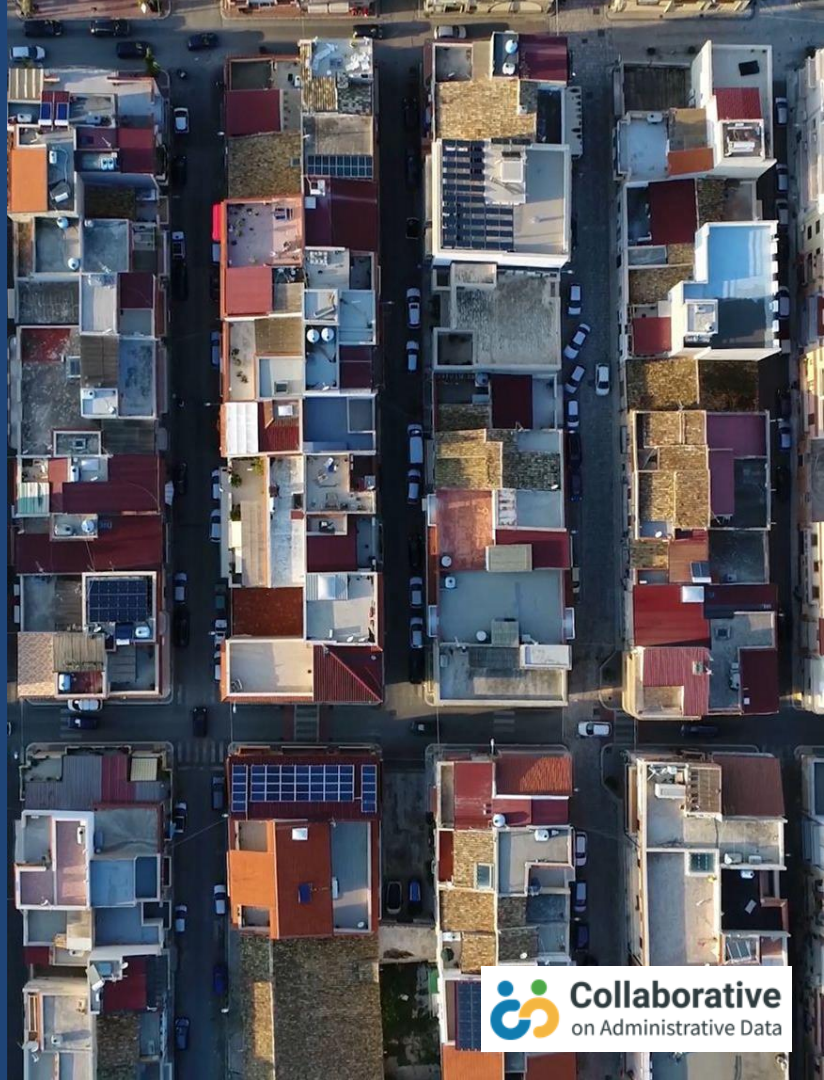

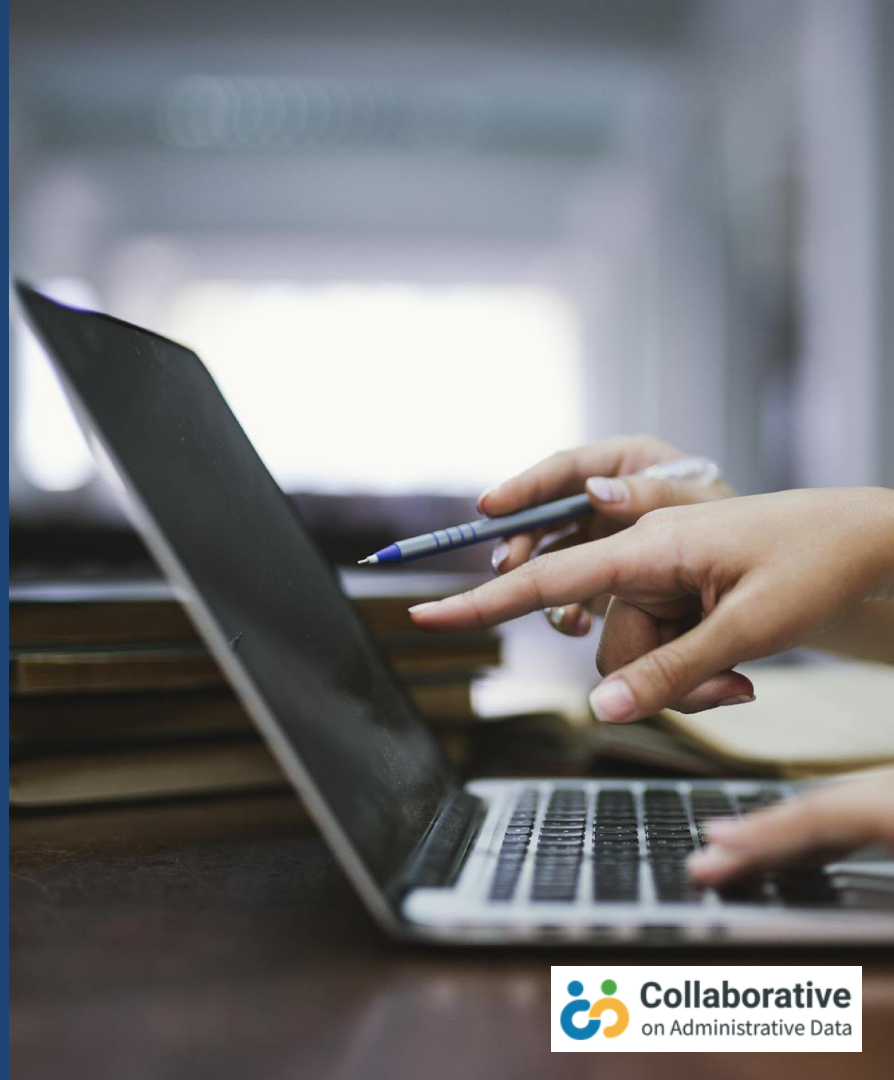
Collaborative on administrative data - background

- Multi-stakeholder collaborative of countries (mainly NSOs) and regional and international agencies
- Co-led by UNSD and GPSDD
- Endorsed by the UN Statistical Commission



How do we work?

- Space for collaboration and sharing of knowledge and experiences
- Members play an active and leading role
- Process oriented and crosscutting focus
- Builds on advances made in various sectors and by a large variety of partners
- Focus on simple, ready-to-implement solutions that address priority gaps as defined by members



How we are organized: task teams & workstreams

- Task team 1: Institutional framework, coordination and partnerships
- Task team 2: Data management and standardization
- Task team 3: Technical interoperability and linking

Workstreams: To enable members to work across task teams, and to focus on one concrete task. They focus on a specific activity; with more specific deliverables & are timebound.

- Communications, Advocacy & Fundraising;
- Workstreams on Data Quality; Data standards & classifications upcoming

- Members from more than 25 countries and as many international and regional organisations
